- 3.6.4 All Bespoke offerings are limited to availability.

#### **4. Membership Entitlements**

4.1 Offensive or aggressive behaviour (including but not limited to, yelling and swearing when dealing with Yarra Bend staff, Yarra Bend representatives or contracted staff) will not be tolerated. Members who consume alcohol on the premises are to do so responsibly. Drunkenness will not be tolerated. Members who breach the behaviour code of conduct may face penalties including cancellation of Membership without refund.

#### **5. Transferability and on selling**

5.1 The benefits associated with being a Yarra Bend Member are strictly for personal use only and may not be transferred to another person under any circumstances, without prior written consent from Yarra Bend. Lending, sharing or transferring the benefits of the Membership or the physical membership card is considered a breach of membership and will result in the immediate cancellation of the membership. Refunds **will not** be available for cancelled memberships due to breach of terms and conditions. Yarra Bend Golf staff will conduct regular ID checks where deemed necessary.

#### **6. Lost or stolen Membership Cards**

6.1 Should a member's card be misplaced or stolen, the member will be assigned a new card at a replacement cost of \$5

#### **7. Membership Payment Methods**

7.1 A member is entitled to pay in full upon purchase of membership or pay membership fees via weekly or monthly direct debit from either a nominated bank account or credit card.

7.2 All direct debit arrangements will incur further payment processing fees, disclosed on the direct debit application form. If a member's direct debit arrangement defaults through the payment, Yarra Bend Golf has the authority to temporarily halt all membership privileges until such time this can be rectified. The member will be notified in writing should this be applied.

7.3 All Yarra Bend Membership's both course and/or #365UNCAPPED Driving Range are signing up for a 12-month period, all members will be contacted closer to the membership expiry date to confirm if they wish to continue the existing membership or upgrade to a new membership type.

7.4. Where a member wishes to amend their membership, the amendment must be approved via written communication by a representative of Yarra Bend. Additionally, the member will forfeit all prior signed conditions of the previous membership and be held by the new conditions.

**8. Membership Amendments**

8.1 Membership alterations are no official without written consent of a Yarra Bend Representative.

8.2 Memberships can only be altered if the member wishes to expand their Membership Alternatives.

8.3 All Membership Alterations will be found financially by Section 7.

**9. Cancellation Policy**

9.1 Yarra Bend Golf reserves its right to cancel a member's Club Membership without a refund where that member is deemed by the Club to have breached these Term's and Condition's (including where that member attempts to transfer or sell their club Membership and/or associated benefits).

9.2 No cancellations will apply without prior written consent from a representative of Yarra Bend Golf.
